5. Commodore's Report

Mr President and fellow members,

Well, what a season, in spite of turbulent weather patterns and wind directions, I am pleased to report a reasonably successful sailing season and that our club continues to flourish.

All our eight committees are vibrant and pro-active and a big thank you to all who have been involved with the organisation and running of our club, including:

- Sailing
- House
- Health and safety
- Training
- Junior
- Governance
- Environmental
- Communication

These eight feeds into the general committee which meets on a monthly basis.

Our website continues to provide updated information about our club and its activities. I urge you to log on at regular intervals e.g., weekly as for example our galley 'specials' menu ordering form changes each week.

Many thanks to our webmaster who continues to do a fabulous job.

We now have over five hundred members ranging from those starting out on sailing and water activities to more experienced members most of whom comment on how friendly and hospitable our club is.

We continue to be a self-help club, which strives to be an affordable sailing community offering excellent facilities with a full and comprehensive programme including dinghies, cruisers, paddleboarding, kayaking and rowing.

At this point, I would like to highlight the work of the health and safety committee which has nearly completed reviewing and revising all our health and safety documentation. This is a very important job. I am also pleased to report that we continue to be an accredited RYA training establishment.

Another highlight was the official opening of the Toby Hamer room during junior week. Many members have also enjoyed sitting in the sunshine in the new western deck which overlooks Langstone harbour and others have appreciated some impressive sunsets.

Paddleboard orienteering was a new event on the calendar which we hope will gain a few more members interest.

Another first was the photographic competition and although there were only a few entries, the standard was high. The winning entry was judged in the Chichester harbour photographic competition and given a highly commended award. I hope that this competition becomes an annual event.

I am pleased to report that cruiser rallies have gone from strength to strength with over 50 boats and a hundred sailors enjoying a combination of local and further afield destinations.

The membership survey that you were asked to complete is now being analysed and will influence future planning.

Sailing club manager software which we have been using for some time now enables us to review the duties carried out by members during the year. This will enable us to accurately target the few individual members who do not appear to be making a contribution to the club.

I am sure that you will remember that in a previous report, I highlighted the concerns about increasing energy costs and as predicted our energy costs have increased. We have now changed supplier and fitted a smart meter and costs have not increased as much as feared. Following a long and detailed discussion about expenditure at the October GCM the committee agreed that we need to increase fees in the region of 10% next year. We will not be informed by Chichester harbour conservancy of the fees for moorings until after their meeting in November, so we may need to increase our cruiser mooring fees appropriately. We must still be mindful of energy costs ensuring that we keep our usage under control.

You may also remember that at the previous AGM we thanked our retiring Bar manager and gave him a gift of garden furniture. I am pleased to tell you that he sent me an email and expressed his surprise and thanks for such an unexpected gift.

We still have some vacancies in the organisation and Larry would like to retire as club secretary if somebody would like to step up. We also urgently need an I.T manager.

Before, I finish I must mention our Cruiser Lift Out Team, who produced a magnificent effort in highly challenging conditions, a great effort all round, well done all!
